- Branches are geographically assigned to Regions.




### **RTO Membership**

All teachers who are in receipt of a pension from NSTPP in Nova Scotia are eligible to become an RTO member on retirement.

Retired teachers may join later if they did not join at retirement.

Teachers who have taught elsewhere may join the RTO as an Affiliate Member.

- Opportunity for social connections with other RTO members in your Branch
- Deals and Discounts similar to those enjoyed as an NSTU member
- The Retired Teacher, our RTO newsletter, produced 3 times a year: Spring, Fall and Winter issues
- A voice on provincial matters related to seniors The RTO is a member of the Senior Advisory Council of Nova Scotia which advocates for seniors on issues such as health and social welfare in NS
- A voice on federal matters related to seniors As a member of ACER-CART, the Canadian Association for Retired Teachers we work on behalf of our members on issues such as health, pensions, a National Pharmacare, elimination of elder abuse and a National Seniors' Strategy
- Finally, RTO membership provides an opportunity for leadership at both the Branch and at the provincial level.

## **Branch Structure**

Branches have their own Executive and budget.

Each Branch receives an annual grant from the Provincial RTO based on their membership numbers.

Branches organize activities for the members in their Branch – meetings, workshops and social events.

Branches can also apply for additional funding through the Branch Initiative Program (BIP) grants to conduct special events and activities.

- Volunteer possibilities and leadership opportunities





#### **RTO Provincial Standing Committees**

- Several committees support the work of the RTO with members selected from across the province. Members serve for a year with the option to apply for a second year.
- Each spring following the AGM there is a call for applications for standing committee members.
- Each committee is chaired by a member of the Executive
- Committees meet 3 to 4 times a year.

Committee work is an excellent way to gain experience and to understand how the RTO works at the provincial level.

#### **About These Committees...**

**Communications Committee** - Working with the newsletter editor, provides support for the publication of each issue; working with the webmaster, provides up-to-date information on issues on the website (rto.nstu.ca)

**Membership Committee** - Promotes membership in the RTO and recruitment and support Branch membership updates. They identify RTO merchandise to be made available to members.

**Pension and Benefits Committee** With a mandate to study and respond to pension and benefits concerns, they represent the RTO on the NSTU Pension Committee and other related pension and benefits issues.

**Programs Committee** - Organizes a bi-annual provincial symposium on wellness themes. Coordinates programs and/or workshops as determined by the Executive.

**Research and Review Committee** - Researches and analyzes the effectiveness of the programs offered by the RTO.






## **Provincial RTO Activities**
